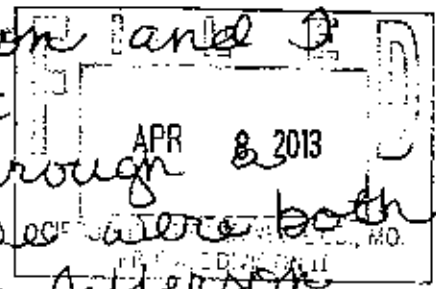


My name is Brenda A. Williams and I  
in a friend of Allie Overstreet  
We met in ~~the~~ April 2012 through  
family rights advocacy group we were both  
involved in. We went together to Jefferson  
City, Mo on October 31st to film our stories for  
documentary called Lawless America and  
rats where we both met William Windsor for  
the first time. After the day we filmed, Allie  
became very involved with the Lawless America  
movement. Mr. Windsor praised her online many  
times. She became the Missouri State coordinator  
as a huge part of organizing Mr. Windsor's "Meet  
in DC" event, and Mr. Windsor publicly posted  
she was his "assistant". I spoke to Allie several  
times on the phone during this time and she  
confided to me her concerns that Mr. Windsor  
was not telling the truth about many things  
we posted online and we both agreed we did not  
like the way he deleted, then publically bashed  
anyone that disagreed with his opinions or his  
actions. I saw several people that started out  
being involved with Lawless America and had been  
filmed for the documentary, have their clips on  
Youtube removed, banned from Mr. Windsor's groups,  
had their pictures and addresses posted publicly  
online and slandered beyond belief. I decided  
early on not to be involved in the internet bullying  
and both Allie and I had talked about this many  
times. Around the beginning of February, 2013, Allie  
had expressed that she did not agree with how  
Mr. Windsor was treating people and immediately was  
also "kicked" from S.A. Her Youtube videos were (1)

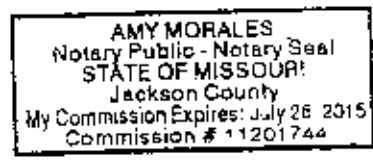
removed and she primary involvement...  
re was no longer involved with Fairless America  
- Mr. Windsor, I am unsure what took place immediate  
forward's, but soon Allie's name was being  
shed all over Mr. Windsor's web sites. He called  
er "mentally ill", a "liar", said she "slandered"  
im and others in the group.

The ~~attack~~ personal attack on Allie online  
of Mr. Windsor and many of his followers was  
discous and constant.

At the end of Feb, beginning of Mar, 2013, I  
is made aware that Mr. Windsor had posted  
at my 17 yr. old son, Noah, had committed suicide  
nd that I had emailed Mr. Windsor via facebook  
th this information. I did not send any message  
Mr. Windsor about my son via facebook or any  
y else and I was very upset because my son  
d attempt suicide and was in a coma in the  
ospital but I had not shared this news with  
yone, including Allie Overstreet. I attempted to log  
to my facebook account and was blocked from  
ong so because my account info had been  
anged. ~~By~~ After some investigation and contact  
th facebook, I learned the account was hacked  
y an IP address in Biloxi Mississippi. Mr. Windsor  
ad called me on the phone after being told  
y son was not deceased and immediately  
arted blaming Allie stating she was severely  
entally ill. I told Mr. Windsor that Allie had  
ccess only to my business page, not to my  
ersonal one, where appearantly the fake suicide  
essage had been sent from and also told him  
hat my account had been hacked from an IP address  
in ~~not~~ but he was convinced Allie sent the msg (2)

1. sabotage him. I stopped answering his calls  
 2. responding to him at all once I realized he  
 as obviously only focused on ways to further  
 lander Allie. He posted several blogs about her  
 blicly posted her home address, email and   
 one number, made indirect threats publicly online  
 nd personally contacted Allie's ex husband with  
 hom she has been in a nasty custody battle  
 ith and told him she was dangerous and  
 mentally unstable. The attacks on Allie by William  
 Windsor and his followers have been vicious and  
 disgusting, putting her and her childrens safety  
 t risk by posting their home address. Mr. Windsor  
 naled me insisting I ~~wrote~~ <sup>sign</sup> a sworn affidavit  
 hat he wrote based on our emails and  
 private conversations or he implied I would  
 -forced to attend the hearing and testify in  
 rson. I ignored this, just as I have several  
 ther messages and have not responded. I would  
 ke for Mr. Windsor to stop trying to contact me  
 any way and this is my sworn testimony.  
 personally believe that Allie Overstreet has  
 legitimate reasons to feel threatened by William  
 Windsor and his followers and is in need of  
 legal protection.
