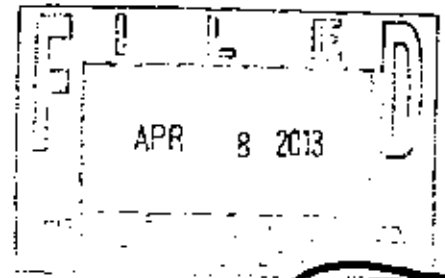


Order of Dismissal
