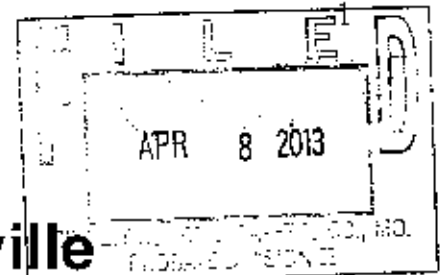

On March 15, 2013 at about 4:00pm, Allie L. Overstreet came to the Higginsville Police Department to report harassment and stalking by William "Bill" Windsor. Overstreet explained that she first became involved with Windsor several months ago while looking for advise and advocacy regarding alleged sexual abuse involving her children. Allie stated that she was upset with family services, juvenile courts and police officers involved in that investigation and reached out to Windsor who advocated for judicial rights. Overstreet alleges that over the next several months, after being recruited by Windsor for his end goal, she believed she was working to bring changes to the family court system. She then states that Windsor lied and miss used her story and goals to support his own agenda to "overthrow the government." She alleges he revealed his extreme views to try all judges for treason and kill all government employees and judges that did not agree with him. Overstreet stated that she severed ties with Windsor and he began to publish lies on his website, www.lawlessamerica.com. She stated that she asked him to stop communicating with her and he then published her address and phone number on the website.

Overstreet's story seemed very complex, so I asked her to complete a written statement regarding her allegations. Overstreet provided me a copy of an Exparte' protection order she received against Windsor. She also provided emails that she said were between she and Windsor showing proof of the harassment and threatening behavior. Overstreet also stated

that Windsor alleged he signed a warrant out for her arrest as she was harassing and threatening him. I located a document published to his website and attached it to this report.

On March 18, 2013, Allie Overstreet brought in her written statement. See next supplement.

I reviewed the www.lawlessamerica.com website and saved copies of information I located related to Overstreet to this report. See attached documents.

Further investigation needed.

Allie Overstreet Statement:

I met Bill Windsor on line when I was searching for like minded people in Family Court Advocacy. Two years ago, my daughter was sexually abused and I reported it. After a year and a half, over a hundred thousand dollars, and stacks of medical records, she was sent to live with her abuser. In the process, I witnessed some of the case workers and police officers lie on reports and omit evidence, as well as fabricate some. It was apparent that the Juvenile and Family court system was easily biased and I was appalled that the hearsay rule applies but due process does not. I began searching for other advocates and partners to change some of the Missouri statutes pertaining to Judicial immunity (police and case workers), changing preponderance of evidence to beyond a reasonable doubt, and working towards a presumption of equal custody rather than mostly mothers. (or in my case, fathers).

Bill Windsor ran a website called Lawless America, that seemed to agree with my findings and changing things in our Judicial system. He did have a much broader scope, including all subjects, not just family law. I began working with him on line by being his volunteer. I answered messages for him and eventually planned his event in Washington DC called Meet Me In DC. I was the Missouri State Coordinator for Lawless America, although that just consisted of him giving me posting rights to his Missouri Lawless America Facebook Page, and answering questions for anyone in Missouri about his group. There were about a dozen Missouri people.

I continued to be a family advocate for Missouri families who were losing their children due to bias and fraudulent case worker reports, going to court with them as support and helping them get through the struggles. While doing so, I recruited many to Lawless America and Bill Windsor.

Two weeks before our DC event, I started noticing that Bill was lying about people online and stalking them out of anger. He had been doing that for the year I worked with him, but I only saw his version of the story. I began to question his motives when he would attack people with lies and malice even though we both knew it was not true. He had been copying me on hundreds of emails. I thought as a safeguard in case he needed proof or his computer crashed. There were so many I did not read them all until he began lying more and more and I questioned him more and more.

Bill had a plan to take over the government, but for a year he explained it gently and I did not disagree. He explained it as replacing all dishonest government employees, judges, politicians,

police, etc, with honest ones. Sounded good. But near the end, approx January, 2013, he began to reveal his extreme views to me and others online. He intends to take over, not vote them out. He intends to try them with treason for simply not answering his letter to them, not sue only those caught breaking the law. He intends to kill all government employees, judges specifically, that do not agree with him. He calls everything treason, even the ignoring of him and his group is treason, according to him.

I had filmed two videos for Bill Windsor, as he advertised he was a big producer and was doing a documentary of court corruption. During filming in Jefferson City on October 31, 2012, he assured me that he would bleep out my daughters name and he would not publish my film until after it was edited to protect us. He posted both, unedited, and I asked him to bleep out my daughters name a few times over a few months. He refused. I did not use my daughters last name or address, and did not use her dads name, but I had been told only one of the videos would be published and it would be edited first.

My ex saw the video, took it as me accusing him more of sexual abuse rather than the intended accusations that family courts are easily biased, and took legal action. I asked Bill to remove my videos and he refused to answer. He did take them down later, when he became mad at me. I wrote to him explaining that the videos were hurting my case, my custody, and therefore my daughter. He ignored.

There are dozens of others that I have spoken to, that he stalked and harrassed online. There are several lawsuits against him for the very same thing as he is doing to me. I did not agree with his plans, they were too extreme for me, and I did not agree with his focus on hate all the time recently. I told him I thought he needed to tone down his hate a bit. That many had come to me and agreed he was focusing too much on every person who may say a bad word about him, rather than on fixing the judicial system. He told me to leave, so I did.

A week went by, and I had been what he called Vice President of Lawless America, (which was just a name since there was no real organization or trade mark or 501(c)3 at that time), and people did not know I was gone. My inbox would fill with their questions and concerns so I asked Bill to make a public announcement that I was no longer with Lawless America. He refused. I made my own announcement in which I said we just disagreed on how to handle the people who did not like him and we had no hard feelings.

Bill saw my announcement and became angry. He began emailing me asking me if my account had been hacked and someone else was posting for me. He began sending me "Cease and Desist" notices, saying if I actually wrote that I was no longer with Lawless America, that he would expose me as a liar and libeler and slanderer. His Cease and Desist notices said do not ever contact him again but when I did not reply, he published to the public that I was refusing to answer his generous attempts for me to tell the truth if I wrote things or not. I did not reply because his Cease notices said he would sue me if I did.

A few days later, I saw he published an article on his website and on his many facebook pages, saying a young boy had committed suicide due to the government intervention in his life. I know the boy well, and his mother. They are a family in Independence, Mo., that I advocate for. I knew his article was not true because I had watched him lie many times before and I had spoken to the boys mother just two hours prior to seeing Bill's suicide notice. I called the mother, Brenda Williamson, to verify her son had not committed suicide within the last two hours. He had not. I then got online and commented under Bill Windsor's suicide announcement that he was lying, how dare he, the boy was okay, etc. I railed him for putting

private information of a minor online for the public without his permission or his moms.

He deleted my comment then published to 50,000+ that I had deleted it myself so I must be guilty of writing the original suicide message. I had nothing to do with the suicide message and didn't know who did it. I wondered if Bill had done it himself. Within the next few days, Bill directed the public who follow his websites that I was a horrible mother, a stalker, a liar, libeler, slanderer, a mentally ill woman, sick, etc, for writing a suicide message about a minor. I did not do any of that.

I shot back a few comments defending myself, and he copied and pasted them in another public article, taking parts out to seem like he was right. I have those in my inbox still. He directed the public to get all the personal information on me that they could, and essentially stalk me and harrass me online.

Bill Windsor wrote several articles about me, telling everyone I was a stalker, etc, and he published my address where my kids live and my phone number. He repeatedly told everyone online that he would work diligently with my ex to see to it that I never saw my daughter again. He repeatedly bragged he had a gotten a gun and was practicing with it. He repeatedly told everyone publicly that I was the writer of the sick suicide message and lying about him, that he was honest and a good guy saving America.

He then sent me emails saying ceast and desist, even though I never contacted him and ignored him. He sent them to dozens of others as well. He contacted my ex offering to write a sworn declaration that I was a bad mom even though he is not a party to my custody case nor has ever seen my daughter. He has done the same thing to dozens, and brags publicly online about sabataging peoples custody cases.

He then wrote and published another article, saying he pressed criminal warrants on me for all kinds of stuff I never did. He continued to post publicly fake emails, altered emails, and some real emails, to get his followers to believe him. They began harrassing and threatening me online.

He then published another article that I had made a facebook account in his dead fathers name to harrass him with it. I did not have anything to do with it, nor do I know who did. I wonder if Bill did that himself too. He published the article everywhere online, saying he has evidence it was me, and I am a dangerous and sick woman. He calls me mentally ill. People believe him. He promises to sabatage my custody hearing.

I told him publicly online to cease and desist and stop publishing lies about me and stop using my kids address. He won't stop.

I have not contacted him but he says I have and says I am making him fear for his life and his family's life, publicly. He brags about his target practice, then publishes he is on his way here.

He threatens to show up at my April first court hearing about my daughter to sabatage it and work with my ex and film the hearing against my will.

He filed real criminal charges against me now, and is suing me for defamation and stalking etc. But I have never done anything other than call him a name or two for lying about me.

Bill has a long history of doing this to others, and there are dozens right now that he is doing it

to. They all gather on a blog online and talk about it but I don't know how many have filed real complaints. He has several lawsuits against him for the same thing and was deemed a vexatious litigant by Georgia courts. He is currently in a lawsuit with Maid of the Mist for fraud etc. He sues everyone for everything. He steals people's money, and private information to use for I'm not sure what. He has huge spreadsheets of thousands of sets of private info including home addresses. He pretends to be a producer of a movie and promises to help desperate people looking for help in the court system and family law area.

Upon google, I see he is tied to much bigger people who claim to be sovereign and going to overthrow our government. He is involved with some sort of bigger operation like a cult. He does a radio show online on Sundays and tapes them but now that he is in what he calls phase two, he stopped recording. He plans to have all his 50k followers file criminal charges against every government judge, prosecutor, politician, cop, etc, on May one this year. He plans to try to make up his own grand juries and try them all for treason and give them the death penalty. He is instructing people how to do it and in what steps.

He will not tolerate anyone saying no to him and if they do, they end up where I am, with his made up lies published online and putting their addresses out online and ruining them. Several are there now with me.

I am scared one of his followers will do something to me or my kids, and come to my house. He attracts very unstable people and some are moreso than others. Very extremist ideas. Most of the honest but desperate parents have left him and he remains with the extremist bunch that agree in killing judges.

I am scared he is in fact impacting my custody case of my innocent daughter, and that my ex's lawyer Kelly Rose will use this as a bad strike against me. That he will really show up in town on my hearing. That he will keep printing lies about me.

He has been served with my restraining order because he has stopped contacting me but instead now contacts my friends and posts indirectly rather than directly. He posted today that his Georgia judge told him to buy a gun and practice with it and that he is coming to Missouri to see "someone in particular". He emailed my friend saying she should help him sue me but she is not interested and agrees he is a cyber bully.

Here is the message from Allie:

"Windsor will not remove pictures of my son from his facebook pages and I cannot ask him to because he put a protection order on me. He published today, 4/1/13, my address, private cell phone number, my work phone number, private case number, lies, his court filings, and exact words my daughter said to me when she disclosed her sexual abuse last year. Windsor is under an active protection order that I filed and is breaking it daily. He is aware posting my daughters words will hurt my custody case because I told him before he ousted me from his group. He knows I have pending court action and all content about my daughter must be removed from the internet. He removed it but now that he is trying to hurt me, he reposted it knowing it will stop me from being able to see my daughter. He vowed to sabotage my custody case and he is doing it. He sent a person from KC to serve me a paper ordering me to meet him in his hotel room when he knows i have a protection order against him and he tried to serve me with an envelope full of cash bills for travel to his hotel room in Independence alone, to meet him to be filmed giving him a deposition. He did this after the protection order was served and after he was notified that the judge denied his request to make me give him a depo. He published today my son, pictured, and the case number and info to my sons recent arrest and incarceration which is completely unrelated to him. He is scaring me and I am staying somewhere besides my house for a week while he is in Higginsville and Lexington. I am scared he will come to my house and try to hurt me or start trouble or try to film me on

camera. He publishes daily about me, while under the protection order. He files dozens of motions in the court in Lexington. He exaggerates my words and adds words. He alters emails sent months ago by adding bad words onto the end. I am scared some of his extremist followers will come to my house and harrass or hurt me. He keeps posting my address with instructions to hate me. These people are not very stable. They believe stuff like conspiracy stuff and breaking the law because they say they are exempt from the law. He keeps pulling his gun comments off line and saying he never bragged about the gun and how he was bringing it to visit all his stalkers. I don't stalk him but my name is on his list. Court with him is April 8. I am scared to go. I know he can't hurt me with people around but I am scared he will snap and do something crazy and I'm scared he will sabatage my case with my baby daughter. I publishes he is contacting every Missouri media site to tell them I am a liar. But I have not lied. I have not done anything to him other than a few facebook posts where I call him a liar and a scam. He is using me and this crazy story to get more likes and comments and stir things up. He does it every time his online followers slow down. I saw him do it to several people right before me. "

On 04/05/13 I met with Overstreet about this case. I explained that on 04/03/13 I met with Lafayette County PA's and explained this investigation. It was advised that at this time no crime has been committed by Windsor and that his activity appears protected 1st amendment free speech. I advised Overstreet that Windsor's behavior might be considered inappropriate but not criminal at this time. I advised her that civilly she could pursue a case against Windsor if she feels he his printing or stating lies, but it was not a criminal issue.

No further investigation will be conducted at this time.
