1 MR. WINDSOR: It's July 14th, 2013. We're  
2 at the offices of Cross Reporting Services, 306  
3 Southeast 291 Highway in Lee's Summit, Missouri.  
4 It's now ten minutes after the hour of 1:00  
5 o'clock. We were here prior to 1:00 o'clock for the  
6 start of the deposition of Defendant Allie Loraine  
7 Yager Overstreet in Case No. 13LF-CV00461 in the  
8 15th Judicial Circuit, Lafayette County, Missouri.

9 You don't see anybody but the court  
10 reporter here because I'm behind the camera and the  
11 chair to the court reporter's right is where Ms.  
12 Overstreet would be, had she shown up.

13 I've marked as Deposition Exhibit 1, and  
14 we'll give the court reporter, the Notice of  
15 Deposition of Defendant Allie Loraine Yager  
16 Overstreet. She was served with this on the 2nd of  
17 July. Her alleged attorney, Matthew J. O'Connor,  
18 has acknowledged, and as has his assistant, the  
19 receipt of the Notice of Deposition. They indicated  
20 that Ms. Overstreet had a prior commitment today.

21 I asked, "Well, what's that prior  
22 commitment that would take precedence over a legal  
23 proceeding?"

24 There was no response. I asked that  
25 several times. They failed to respond.

1           The assistant then claimed that Mr.  
2 O'Connor had a Court hearing on Monday and so would  
3 not be able to do it with a continuation on Monday,  
4 or start on Monday, as it was originally set to be  
5 continued on Monday. I asked for the name of the  
6 Court, the name of the Judge, and the case number.  
7 There was no response.

8           I then had some e-mails with Mr. O'Connor  
9 where he refused to provide that information. I  
10 doubt seriously that he has a hearing. And he then  
11 filed a motion with the Court claiming that I was  
12 seeking attorney/client privileged information about  
13 his clients. Well, there's nothing attorney/client  
14 privileged about a Court, a case number and a  
15 judge. It's a matter of public record, and he has  
16 to have some plausible excuse for why he's not  
17 here.

18           So they failed to show up for the  
19 deposition, just as they failed to answer  
20 Interrogatories or respond properly to requests for  
21 production of documents.

22           So we don't have anybody to swear in.  
23 Donna, anything you need to say or do?

24           COURT REPORTER: Nope.

25           MR. WINDSOR: Okay. Then we'll call it a
